2023 VENDOR AGREEMENT

By my signature below, as an individual and/or as authorized representative for my company, if applicable, (“vendor”), I acknowledge and confirm that I have read and agree to the following terms regarding and (and or company’s if applicable) participation in the 2023 Aurora Colony Days Food Vendor in the Park:

1. Vendor shall be fully and completely responsible to enter and use City of Aurora streets, park and property in a responsible and respectful manner at all times.
2. Vendor shall be solely responsible for any and all extraordinary damages beyond normal wear and tear caused by Vendor to the City of Aurora streets, park or property. Vendor understands that Vendor enters into and uses the city streets and property for the limited purposes of participating in the Concerts in the Park and/or Aurora Colony Days Food Vendor in the Park completely at Vendor’s own risk.
3. The City of Aurora and its volunteers make no representations or warranties whatsoever, and assume no responsibility or liability to the Vendor, any persons or animals in Vendors party, any visitors, any other vendors, and/or any third party for any personal or property damages, lost profits, lost opportunities, or any indirect, special, incidental, consequential, punitive, or any other damages whatsoever.
4. I hereby grant full permission to the City of Aurora to use any photos, taken by our appointed photographer(s), or any other record of this event for any purpose whatsoever.
5. Vendor agrees to hold the City of Aurora, its officers, employees and volunteers harmless, and to the fullest extent of the law. Vendor shall indemnify the City, its employees, and volunteers against and all liability for tort or contract liabilities arising from the Vendor’s presence on or use of City’s streets or property. The City, by and through its officials and volunteers reserve the right to terminate the vendor’s right of entry and use privileges at any time verbally or in writing.
6. This agreement shall be governed by the laws of the State of Oregon. Should any legal action, including appeals, be brought by either party for breach of this agreement or to enforce any provision in it, the prevailing party in this action shall be entitled to responsible attorneys’ fees, court costs and related costs.
